

Dear Parents and Carers

The school has received many letters of support over the last week, thank you all for these.

It has been delightful to receive Year 10 and 12 students into school this week and to see the students in lessons once again. We also welcomed back Year 9 for academic mentoring. One or two Year 9 students looked a little anxious before their interviews, but it is pleasing to see their positive responses afterwards. The academic review conversations have been very rewarding.

Last week KS3 took part in consolidation week. For some youngsters this week provided an opportunity for them to catch up with previous work. I know from the email traffic that a number of parents have thanked us for this approach. I normally start writing my Tuesday letter on Sunday evening, this week however I have put this off, waiting for the guidance on school opening for September 2020. On the assumption that we can bring students back into school, we would like to phase students back into school:
